Please mail this check to the Foundation at its address above. This deposit will be refunded if no damage is detected by the Foundation. If damage occurs, funds will be used to make needed repairs and the balance of the damage deposit refunded after the repairs are made.

If music arrangements are greater than those outlined in the attached rules and regulations for Christ Church, Lancaster, an additional payment, agreed to in advance, must be made to the Grace Episcopal Church Organist prior to the wedding rehearsal.
